Pursuant to TMBP § 1212, Applicant, by and through its Attorney-of-Record, respectfully requests the Board to lift the Suspension and Remand the application to the Trademark Examining Attorney for further consideration, stating as follows:

1. On November 16, 2005, the Board suspended the instant appeal pending possible cancellation of Registration No. 2242724 under Section 8 of the Act, 15 U.S.C. § 1058. The registration was cited by the Trademark Examining Attorney as a Section 2(d) bar to registration of Applicant's mark.
