
MOTION TO AMEND RECITATION OF GOODS

Applicant, Pacific Cycle, LLC (“Applicant”) hereby moves the Board, pursuant to 37 C.F.R. § 2.133(a), to amend the recitation of goods in the above-identified application from “motorcycles, electric motorcycles, all terrain vehicles, electric all terrain vehicles, motorized folding scooters, mopeds, electric mopeds, motorized scooters, and structural parts for all of the above” in International Class 2 to: “mopeds, electric mopeds, motorized scooters, and structural parts for all of the above,” in International Class 12. Applicant states that the amended recitation of goods restricts the goods as recited in the application as filed and does not expand the goods as filed. Applicant respectfully requests remand of the case to the Examining Attorney if the Board deems it appropriate under the circumstances.

In view of the foregoing, Applicant respectfully requests that the recitation of goods in the above-identified application be amended to: “mopeds, electric mopeds, motorized scooters, and structural parts for all of the above,” in International Class 12.
