#### **APPEAL BRIEF**

This Appeal Brief is in support of Applicant's Notice of Appeal filed on May 22, 2006, from the Examining Attorney's Office Action dated November 20, 2005, finally refusing to register Applicant's "ALARMAX" mark.

#### THE MARK

Applicant seeks registration on the Principal Register for the mark "ALARMAX" for use in connection with wholesale distribution featuring security systems and alarm equipment.

#### **REFUSAL TO REGISTER**

The Examining Trademark Attorney has refused registration of Applicant's Mark pursuant to Section 2(d) of the Trademark Act, 15 U.S.C. § 1052(d), on the ground that "the mark for which registration is sought so resembles the "ALARMEX" mark shown in U.S. Registration No. 1,784,455 (hereinafter, "the '455 mark") as to be likely, when used in connection with the identified services, to cause confusion, or to cause mistake, or to deceive." *See* Office Action emailed November 30, 2005. The services identified in the '455 mark<sup>1</sup> are not the same as those identified in Applicant's application Serial No. 78/479366, and those of the current owner of the '455 mark are even further from those of Applicant.

#### **ARGUMENT**

### I. The Standard To Support A Refusal To Register Pursuant to Section 2(d)

To support a refusal to register pursuant to § 2(d), the Patent and Trademark Office must show that Applicant's mark is likely to cause confusion among potential purchasers. A likelihood of confusion is synonymous with a probability of confusion. To sustain a § 2(d) rejection, it is not sufficient for the Official Action to show that confusion among potential purchasers is "possible." *Am. Steel Foundries v. Robertson*, 269 U.S. 372 (1926). The mere fact that a mark may call to mind a particular image or recollection is not the degree of confusion required to bar registration under § 2(d). *Viacom v. Komm*, 46 U.S.P.Q.2d 1233 (TTAB 1998).

To merit registration, it is only necessary that a reasonably prudent purchaser is *not likely* to be confused. In determining the likelihood of confusion among potential purchasers, the Office is to consider factors identified in *DuPont* as they may be applicable. *See In re E.I. DuPont de Nemours & Co.*, 476 F.2d 1357 (C.C.P.A. 1973).

#### II. Arguments That Support Registration Of The "ALARMAX" Mark

A. Applicant is unaware of any instances of actual confusion between Applicant's mark and the '455 mark during fourteen years of concurrent use.

Examiner alleges in the final Office Action that Applicant's mark and the '455 mark are "essentially phonetic equivalents" and supports this allegation by stating that "[s]imilarity in sound alone may be sufficient to support a finding of likelihood of confusion." *See* Office Action emailed November 30, 2005. However, Examiner fails to consider that each case of likelihood of confusion between marks is decided upon the particular facts of each case and that "various evidentiary factors may play or more less weighty roles in any particular determination." *In re Shell Oil Co.*, 992 F.2d 1204, 1206 (Fed. Cir. 1993) (citing *In re DuPont*, 476 at 1361-62, 177 USPQ at 567; also citing *Nina Ricci, S.A.R.L. v. E.T.F. Enter., Inc.*, 889

F.2d 1070, 1073, 12 USPQ2d 1901, 1903 (Fed. Cir. 1989). Therefore, a simple comparison of the sound of Applicant's mark to the '455 mark is not sufficient to determine if there is a likelihood of confusion.

In particular, *DuPont* instructs that two factors that should be considered in evaluating likelihood of confusion are the nature and extent of any actual confusion and the length of time that the marks have been used concurrently without evidence of actual confusion. In re DuPont, 476 F.2d at 1361. It is notable that Applicant and registrant of the '455 mark have been using their marks concurrently since 1992 with no known instances of actual confusion. "[T]he absence of any evidence of actual confusion over a substantial period of time...creates a strong inference that there is no likelihood of confusion." Carefirst of Maryland, Inc. v. First Care, P.C., 434 F.3d 263, 269 (4th Cir. 2006) (finding no likelihood of confusion where the marks were used concurrently for nine years without any instances of actual confusion); see also Amstar Corp. v. Domino's Pizza, Inc., 615 F.2d 252, 263 (5th Cir. 1980) (finding no likelihood of confusion where there were only three instances of actual confusion over a period of fifteen years of concurrent use of the marks). Examiner's statement that "[c]onsumers will call for applicant's services and registrant's services by the highly similar wording," Office Action emailed November 30, 2005, is completely unsupported and without merit. In fact, that Applicant and registrant have used their marks concurrently for more than fourteen (14) years without any known instances of actual confusion strongly suggests that confusion between the marks in the future is highly unlikely. "A mere assumption that confusion is likely will rarely prevail against uncontroverted evidence from those on the firing line that it is not." In re DuPont, 476 F.2d at 1362.

B. The nature of the goods or services described in Applicant's application and the '455 registration and the purchasers of those goods or services are dissimilar.

*DuPont* states that likelihood of confusion may also be determined by the similarity or dissimilarity of the goods or services and the buyers to whom sales of such goods or services are made. *Id.* at 1361.

Examiner has alleged that Applicant's and registrant's services are "highly related."

Office Action mailed November 30, 2005. This statement is unsupported. Applicant is a distributor of security systems and alarm equipment to licensed dealers and installers.

Applicant uses its mark to promote its distributorship services to licensed dealers and installers only. For example, Applicant's online catalog can only be accessed by licensed dealers/installers who have an account, user name, and password registered with the company. In contrast, registrant of the '455 mark offers commercial-grade security solutions tailored to retailers.

Thus, Applicant's and registrant's services do not overlap and as such there is little likelihood of confusion between their marks.

Further, where the predominant consumers of goods or services are different, "the possibility of confusion, mistake, or deception" is lessened. *Amstar*, 615 F.2d at 262. Applicant and registrant offer their services to different target markets. Applicant and registrant operate at different levels in the broad security system industry and sell to two completely distinct sets of buyers. *See, e.g., Homeowners Group, Inc. v. Home Mktg. Specialists, Inc.*, 931 F.2d 1100, 1109 (6th Cir. 1991) (noting that Plaintiff who offered marketing and advertising support services for

real estate brokers offered a different service than Defendant who rendered real estate brokerage services on a flat-fee or commission basis). Specifically, Applicant's target market is licensed dealers and installers, while registrant's target market is retailers seeking commercial-grade security systems. In fact, Applicant sells only to licensed dealers and installers such as registrant itself. Therefore, because registrant is the very type of customer that Applicant distributes to, it is unlikely that Applicant and registrant are competitors and therefore confusion between their marks is also unlikely. *See, e.g., Pharmacia & Upjohn Co. v. Generation Health*, 44 USPQ2d 1091 (W.D. Mich.) (noting that two drugs did not directly compete where one was marketed to a "narrow universe" of professionals who sell or prescribe the drug and the other was available over the counter). There is little chance of confusion between Applicant's mark and the '455 mark because the predominant purchasers of the services associated therewith are different.

#### C. The '455 mark is a weak mark.

"[T]he strength and distinctiveness of [a] mark is a vital consideration in determining the scope of protection it should be accorded. Strong marks are widely protected, as contrasted to weak marks." *Amstar*, 615 F.2d at 259. The '455 mark, "Alarmex," is a weak mark because others who appear to be unrelated to registrant use "Alarmex" in conjunction with alarm services. Importantly, it does not appear that registrant even uses the '455 mark in association with its security goods or services because a search for "ALARMEX" on registrant's website did

A printout from a "Google" search of the term "Alarmex" is attached as Exhibit D. It does not appear to Applicant that any of the results refer to registrant's '455 mark.

not produce any results.<sup>8</sup> Further, none of the search results on "Google" appear to be instances where registrant is using the '455 mark in conjunction with such goods or services that are publicly available. One notable use of "Alarmex" by one other than registrant is Alarmex, Inc., an apparently unrelated Massachusetts company that installs commercial and residential fire and security systems for a wide base of customers.<sup>9</sup>

In contrast, a search of "Alarmax" on "Google" only produces distributors affiliated with Applicant. <sup>10</sup> In fact, Applicant's mark and the services it provides are well-known and extensively used throughout the United States. It has branch offices in California, Georgia, Maryland, Massachusetts, Nevada, New Hampshire, New Jersey, Ohio, and Pennsylvania. <sup>11</sup>

Because the '455 mark is a weak mark, it should not be afforded a broad scope of protection and Applicant's application for "ALARMAX" should be allowed.

D. Neither Applicant nor registrant has expanded its services to include those offered by the other in the past fourteen years.

Another factor that is considered in the likelihood of confusion analysis is the expansion in the types of goods or services provided by the parties. *In re DuPont*, 476 F.2d at 1361. Here, Applicant and the registrant of the '455 mark have been using their respective marks concurrently for more than fourteen years and neither Applicant nor registrant has expanded the services offered to include those offered by the other party. In fact, it should be noted that the current registrant of the '455 mark, which actually purchased the former registrant of the mark, is a

global corporation that is strictly service-oriented. <sup>12</sup> As such, this factor also mitigates against a likelihood of confusion.

E. Additional factors also support a finding that there is not a likelihood of confusion between Applicant's mark and the '455 mark.

other probative factors in addition to those that the court enumerated. *In re DuPont*, 476 F.2d at 1361. In *Amstar*, the court considered in its likelihood of confusion analysis that the U.S. Patent Office made an initial determination that the mark at issue was entitled to registration. *Amstar*, 615 F.2d at 261. In the instant case, Applicant previously owned a registration for the "ALARMAX" mark for these exact distributorship services that was unintentionally not renewed due to circumstances beyond its control (Reg. No. 1,788,670; registered August 17, 1993). Applicant filed its original application approximately one month after registrant filed its application for what is now the '445 mark, yet the Examiner in that case did not cite registrant's pending application as being likely to cause to confusion with Applicant's mark. This prior registration further supports a finding that there is little likelihood of confusion between Applicant's mark and the '455 mark.

#### III. CONCLUSION

Applicant's "ALARMAX" mark does not create a likelihood of confusion among potential purchasers. First, Applicant is unaware of any instances of actual confusion between Applicant's mark and the '455 mark during fourteen years of concurrent use. Second, the nature of the goods and services described in Applicant's application and in the '455 registration, and

the purchasers of those goods and services, are different. Additionally, the '455 mark is a weak mark. Furthermore, neither Applicant nor registrant have expanded their services to include those offered by the other in the past fourteen years. Finally, the Patent and Trademark Office previously recognized that Applicant's "ALARMAX" mark was entitled to registration despite the '455 mark. For at least these reasons, Applicant is entitled to registration of the "ALARMAX" mark on the Principal Register and such registration is respectfully requested.


