The applicant amends the goods description to limit the list of goods to "vodka of Russian origin". Applicant believes that the designation «Русское золото» is a fantasy one in respect of "vodka of Russian origin". It is respectfully submitted that accordingly, the rejections are overcome and that the application is in condition for further processing and proceedings to advance to publication.

An appeal is submitted herewith with request for reconsideration to keep the application pending while the response is considered.
