## **Notice of Appeal**

Notice is hereby given that Aloys F. Dornbracht GmbH & Co. KG appeals to the Trademark Trial and Appeal Board the refusal to register the mark depicted in Application Serial No. 79097074.

Applicant has filed a request for reconsideration of the refusal to register, and requests suspension of the appeal pending consideration of the request by the Examining Attorney.

The refusal to register has been appealed as to the following class of goods/services:

Class 011.

All goods and services in the class are appealed, namely: Electric and electronic sanitary fittings in the nature of plumbing fittings, namely, shower control valves, couplers, bibbs, faucets, taps, stoppers, mixers for regulating flow, distribution, and temperature of water, shower heads, sets comprising shower heads, shower riser rails and parts and fixtures therefore sold as a unit, sets comprising handheld shower heads and parts and fixtures therefor all sold as a unit, shower control valves, thermostatic valves, for supplying, distributing, controlling and regulating water; apparatus for lighting, heating, steam generating, cooking, refrigerating, drying, ventilating, water supply and sanitary purposes, namely, plumbing fittings in the nature of drains, faucets, faucet filters, spouts, sink strainers, traps, taps, stoppers, mixer faucets for water pipes for regulating flow, distribution, and temperature of water, shower head sets comprising shower heads and parts and fixtures therefor all sold as a unit, shower control valves, thermostatic valves; sanitary fittings of metal and plastic for toilets, bathrooms and kitchens, namely, plumbing fittings in the nature of shower control valves, couplers, bibbs, faucets, taps, stoppers, mixers for regulating flow, distribution, and temperature of water, shower heads, sets comprising shower heads, shower riser rails and parts and fixtures therefore all sold as a unit, sets comprising hand-held showerheads and parts and fixtures therefore all sold as a unit, shower control valves, thermostatic valves, for supplying, distributing, controlling and regulating water, including for regulating water temperature; instantaneous water heaters, water treatment equipment, namely, water filtration units; wash-hand basins as parts of sanitary installations, washstand installations, namely, bidets, wash stand storage units sold as a unit with the sinks: toilets, urinals, toilet seats, preassembled installation units for showers, namely, portable showers. shower devices, namely, shower heads, sets comprising shower heads, shower riser rails and parts and fixtures therefore all sold as a unit, sets comprising handheld shower heads and parts and fixtures therefor all sold as a unit; wall lights, ceiling lights; shower cubicles of plastic with integrated shower fittings and shower installations; sanitary fittings of metal, plastic and glass, namely, bath tub handles; components for sanitary installations, namely, assembly elements in the nature of plumbing fixtures, namely, shower and bathroom footings, supports, anchorages and mounts for washbasins, mounts for shower stalls, mounts for bath tubs, mounts for toilets, mounts for bidets, mounts for urinals, pedestals for washbasins, shower panels, pressure regulators, shower mixers for sanitary units; connecting pillars for sanitary units, namely, vertical support columns made of metal, ceramic, glass, plastic, wood, rock or stone for supporting a sanitary installation and for housing a water pipe for supplying the sanitary installation with water; bath tubs and basins of plastic, ceramic and metal for sanitary purposes, bath tubs and basins with swirl nozzles and/or aerating nozzles; bath tub plumbing fixtures, in the nature of nozzle fittings, namely, nozzle bases, nozzle mounts, nozzle supports, nozzle footings and heat pumps for bath tubs with swirl nozzles; blowing machines, namely, electric heating fans with heating mechanisms for heating the blast air and for aerating bathing water in tubs; heating mechanisms, namely, electric heating fans and water filters for domestic use for bathing water, steam bath installations and accessories therefor, namely, structural plumbing fittings for steam baths, steam generators, vaporization apparatus, water softening apparatus, namely, bases, mounts, supports, footings; lights for tubs, lights for steam baths and lights for showers; mobile compact-whirl units for fitting in bath tubs, with motors, pumps and nozzle systems for whirling
