**REQUEST FOR EXTENSION OF TIME TO FILE A BRIEF OF APPEAL PURSUANT  
TO TBMP 1203.02 (d)**

Applicant herein, Pilatus Flugzeugwerke AG (“Applicant”), respectfully requests the Trademark Trial and Appeal Board (“Board”) to grant an extension of time to file a Brief of Appeal in the above identified trademark application.

***Status***

Applicant prosecuted the case up until a final request for reconsideration was denied by the Examiner. Applicant had timely filed a Notice of Appeal on October 7, 2020, which Appeal has been reinstated on November 17, 2020 following the denial of the reconsideration request by applicant. Applicant and the owner of the cited references for which a Section 2(d) likelihood of confusion refusal has been issued, Crystal Brand Company (“the Company”), are in negotiations as to Applicant’s use and registration of the above-identified mark.

**Consent**

Applicant and the Company have been in negotiation and a consent and co-existence agreement was submitted to the Company since the Company and Applicant wanted to also settle their dispute over the use and registration in the European Union. Both parties are currently still reviewing the agreement.

Both, Applicant and the Company, are residing in Europe which makes negotiations always more complicated due to the time shifts, the worldwide pandemic, and factors relating to pending applications by both parties in other jurisdictions.

The due date for filing Applicant's Brief of Appeal is January 19, 2021. Applicant hereby requests that the Board grant a suspension of 45 days to file such Brief, if necessary to extend further, so that both counsel can arrive at the co-existence agreement desired by both parties and such action is respectfully solicited.
