Notice is hereby given that NITTO DENKO CORPORATION (NITTO DENKO KABUSHIKI KAISHA) appeals to the Trademark Trial and Appeal Board the refusal to register the mark depicted in Application Serial No. 79238018.

Applicant has filed a request for reconsideration of the refusal to register, and requests suspension of the appeal pending consideration of the request by the Examining Attorney.

The refusal to register has been appealed as to the following classes of goods/services:

All goods and services in the class are appealed, namely: Drain outlet cleaning detergents also with disinfecting effect for household use; Laundry bleach; Laundry preparations, namely, laundry detergents also with deodorizing effect; Detergents, namely, dishwashing detergents also with deodorizing effect; Abrasive paper, namely, sandpaper; abrasive cloth; abrasive sand; shoe creams; Cosmetics and toiletries, namely, non-medicated soaps, hair shampoo and conditioner; adhesives for affixing false hair; adhesives for affixing false eyelashes
- Class 020. First Use: 0 First Use In Commerce: 0
All goods and services in the class are appealed, namely: Mattresses; Hat hooks, not of metal; clothes hooks, not of metal; curtain hooks; Parts for windows, not of metal, namely, non metal window fasteners; Cushion tapes and sheets for furniture corners and edges, namely, plastic edgings for furniture in the form of tapes and sheets; Door stoppers of plastic and wood for refrigerators; Hooks, not of metal; plastic caps for soy sauce; door stoppers of plastic and wood; drawer stoppers of plastic and wood; corner cushions for furniture; Anti-tip braces for furniture, namely, non-metal brackets for securing furniture to walls; auxiliary levers for doorknobs, namely, non-metal door handles; towel rack, not of metal; Kitchen clips, namely, plastic clip for sealing bags

All goods and services in the class are appealed, namely: Door mats of metal; floor coverings; floor mats; Toilet mats, namely mats for bathroom floors; Mats, namely, bath mats, yoga mats, prayer mats, horse stall floor mats, adhesive coated contamination control floor mat made of polypropylene that capture particles; Non-slip mats, namely, shower and bath mats; door mats
