REQUEST FOR SUSPENSION OF APPEAL

Applicant appealed from a refusal to register its mark under section 2(d) based, in part, on the mark “inspira| Novaxanthin,” US Trademark Registration No. 4,965,404. The Board suspended the appeal and returned the application to the trademark examining attorney for consideration of applicant’s request for reconsideration. The trademark examining attorney denied the request and the appeal was reinstated. Applicant’s brief is due today, March 22, 2021.

Today, March 22, 2021, your Applicant filed a petition to cancel US Trademark Registration No. 4,965,404 for the mark inspira| Novaxanthin. A copy of the petition is submitted with this request.
