**REQUEST FOR EXTENSION OF TIME TO FILE A BRIEF OF APPEAL  
PURSUANT TO TBMP 1203.02 (d)**

Applicant herein, Hottinger Brüel & Kjaer GmbH ("Applicant"), respectfully requests the Trademark Trial and Appeal Board ("Board") to grant an extension of time to file a Brief of Appeal in the above identified trademark application.

***Status***

The application was prosecuted up until a final request for reconsideration, which request was denied by the Examiner. The response time having been exhausted, a number of issues remained with classes 7, 9, 35, 37, 41 and 42 and to keep the application alive, a Notice of Appeal was timely filed on July 12, 2021. There remain a number of discrepancies between the Examiner's proposal and what the current applicant company believes should be recited as the goods and services.

Applicant's representative is in the process to again review the lengthy recitations in classes 7, 9, 35, 37, 41 and 42 and to bring these in compliance with the Examiner's requirements regarding the terminology and if agreement is reached to remand the application to the examination unit to finalize the examination.

The date for filing a brief of appeal is October 25, 2021. Applicant hereby requests that such time be extended to November 24, 2021. Since Applicant's company is a foreign national entity, communication between Applicant and its US attorney involves Applicant's European counsel, which is time consuming. At this time, the US attorney is awaiting instructions from Applicant's European counsel.

Therefore, it is respectfully requested that the time be extended as set forth above.
