Notice of Appeal

Notice is hereby given that CORPORACION DEPORTIVA ATLETICO NACIONAL appeals to the Trademark Trial and Appeal Board the refusal to register the mark depicted in Application Serial No. 85038736.

Applicant has filed a request for reconsideration of the refusal to register, and requests suspension of the appeal pending consideration of the request by the Examining Attorney.

The refusal to register has been appealed as to the following classes of goods/services:

- Class 025.
All goods and services in the class are appealed, namely: Clothing items, namely, socks, sports footwear, shirts, short sleeves undershirts, t-shirts, heels for soccer boots, stockings, soccer gloves, trousers, gymnastics clothing, outerwear, underwear, sports shoes, soles, garments, headbands, scarves, caps, woolen caps, bonnets, jerseys, sweater jerseys, uniforms; clothing used in sports activities, for all types of competitions, namely, shoes, boots, tennis shoes, polo shirts, jackets, sweat suits, socks, bathrobes, espadrilles, bibs not made of paper, headbands, swim suits, caps, slippers, non electric feet heating bags, soccer boots, soccer shoes, scarves, sports and beach shoes, underpants, sports shirts and t-shirts, hoods, vests, shawls, belts, ties, sports outfits, shower caps, earflaps, sport trousers, pajamas, hats, paper hats, sweaters, soccer shoe studs, sport uniforms; spinning shirts
- Class 028.
All goods and services in the class are appealed, namely: Games and toys, namely, domino, table games, toys for pets, toy mobiles, Teddy bears, card games, playing cards, play tokens, tables for table football, rocking horses, feeding bottles for dolls, kaleidoscopes, marbles, kites, dice cups, game tokens, table football, toy balloons, toy vehicles, billiard tables, piñatas, toys for making bubbles, plush toys, puzzles, Chinese checkers, baby rattles, chess boards, flying disks, game balls, spinning shirts, gymnastics and sports elements not included in other classes, namely: body-building apparatus, body-training apparatus, roller skates, knee guards, football gloves, baseball gloves, boxing gloves, protective shoulder pads, boxes for tennis rackets, table tennis rackets, soccer balls, baseballs, tennis balls, toy vehicles, items and for using gymnastics equipments, namely, knee guards, protective paddings, cases for soccer, namely, balls, shoes, gloves, clothing, baseball, namely, balls, shoes, gloves, clothing, namely, boxing, namely, shoes, gloves, clothing, namely, skis, skates, and basketballs; shin pads for athletic use
- Class 035.
All goods and services in the class are appealed, namely: Advertisement, dissemination of advertising material through all media, particularly in the form of thematic messages centered on human and sports values; publicity by means of sponsoring, commercial business management, commercial administration, promotion of products and services of third parties by means of contractual agreements, specially sponsoring and granting of licenses, permitting the partners to become famous or to obtain additional image or sympathy derived from sports and cultural events, mainly international; promotion of someone else's products and services by means of media known as factor of initial interest, leading the public to consider, among a large number of competitors, products and services presented to the public with signs, emblems or messages capable of capturing the public attention; promotion of products and services of third parties by means of image transference, rental of advertising space of all kinds and in all carriers, whether or not digital; business administration of the participation of national or foreign teams in a national or international athletic competition and promotion of the support of those teams by the public and relevant sectors; services of retail store services of sports items, clothing and accessories in general
