## **60 Day Request for Extension of Time to Oppose Upon Consent and Extraordinary Circumstances**

Potential opposer believes that extraordinary circumstances are established for this request by:

- Potential Opposer, through Counsel, filed a Motion for Extension of Time on January 18, 2011 for 90 days until May 11, 2011 which was granted.
