MOTION FOR REMAND TO EXAMINER BRIAN PINO

COMES NOW the Applicant, and pursuant to the Rules of the Trademark Trial and Appeal Board, requests a remand to Examiner Brian Pino to consider a proposed amendment to the description of services as provided in the application. If entered, this would eliminate one of the appeal issues.

Proposed Amendment

The original description of services as filed read:

International Class 35: retail services featuring mineral supplements to promote healthy feet and/or legs of livestock and/or poultry.

During prosecution, Applicant amended the description so that it currently reads:

International Class 35: retail store services, namely providing to customers and potential customers information sheets and fliers featuring mineral supplements to promote healthy feet and/or legs of livestock and/or poultry.

In the Final Rejection, the Examiner rejected the above as beyond the scope of the original description. Applicant now suggests the following slight revision to the original description:

International Class 35: retail store services, featuring mineral supplements to promote healthy feet and/or legs of livestock and poultry

The above description is believed narrower than the original description filed and therefore within its scope and is consistent with the Navarro Declaration of record. It also adapts the Examiner's suggested description verbatim, except for the limitation to "on-line".
