**REQUEST FOR EXTENSION OF TIME TO FILE APPEAL BRIEF
OR TAKE FURTHER ACTION**

To the Trademark Trial and Appeal Board:

In its Order January 2, 2014 the Board granted Applicant's most recent Request for an Extension of Time for filing an Appeal Brief until January 23, 2014 and also stated that if any further requests are sought by the Applicant it must include a detailed explanation concerning steps taken to prepare either a Consent Agreement or an Appeal Brief.

As the undersigned counsel indicated in its prior Motion on Consent for an Extension of Time the parties have reached a settlement agreement. On January 6th, 2014, the Agreement was executed by a R.K. Co.. On January 22, 2014, counsel for R.K. forwarded a copy of the Agreement, executed by a representative of R.K. Co. to counsel for Applicant, and the Agreement has been forwarded by counsel for Applicant to its client for counter execution¹. Applicant is now awaiting receipt of the fully executed Consent to forward to the PTO. As soon as the Consent is received applicant will request a remand of the matter to the Examiner and suspension of the Appeal (in the event that, for some reason, the Consent is not accepted).

In the interim, and because the terms of the Agreement have been agreed on by the

parties and because R.K. Co. has already signed the Agreement it is requested that the PTO grant a further thirty day extension of time to either file an Appeal Brief, or to Remand the Application to the Examining Attorney for further consideration regarding action on the Application. It is requested that the time for filing an Appeal or a Remand be Extended from January 23, 2014 until February 22, 2014.

In view of the above favorable action is requested.


