**THIS TRADEMARK ASSIGNMENT** (the "Trademark Assignment") is made and entered into this 6 day of December, 2016 (the "Effective Date"), by and between Chandru Wadhvani, located at 1560 East 6<sup>th</sup> Street, Corona, CA 92879, U.S.A. ("Assignor"), and The TJX Companies, Inc., a corporation organized and existing under the laws of the State of Delaware, with offices at 770 Cochituate Road, Framingham, Massachusetts, United States ("Assignee") (each a "Party" and together, the "Parties").

**WHEREAS**, pursuant to the Parties' agreement formed on December 6, 2016 (the "Agreement"), Assignor desires to transfer and assign to Assignee, and Assignee desires to accept from Assignor, upon the terms and conditions set forth herein, all right, title and interest in and to the trademarks, both registered and common law, listed in the attached Schedule A, together with the goodwill of any business connected to and symbolized by such trademarks ("Trademarks"),

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

(i) **Assignment of Trademarks.** Effective as of the Effective Date, Assignor, on behalf of itself and its parents, subsidiaries, and affiliates, hereby assigns, sells, delivers, transfers and conveys to Assignee the entire right, title and interest in and to the Trademarks, together with: (a) the goodwill of the business connection with and symbolized by the Trademarks; (b) all registrations and applications for registration, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations based in whole or in part on the Trademarks, and any corresponding rights that are or may be secured, now or hereafter arising or in effect, for Assignee's own use and enjoyment; (c) all rights to sue for any past, present or future infringement, misappropriation, dilution, unfair competition, or other violation of the Trademarks, and to collect and retain all damages and profits related to the foregoing; (d) all rights, if any, in the trade dress, labels and designs associated with the Trademarks; (e) all rights to collect royalties, products and proceeds in connection with any of the Trademarks; and (f) any priority rights that may arise from any of the Trademarks.

(ii) **Recordation.** This Trademark Assignment has been executed and delivered by Assignor to Assignee with the understanding that Assignee may record the Trademark Assignment with applicable governmental authorities. Assignor hereby authorizes and requests the Commissioner of Trademarks of the United States, and any official of any other applicable governmental authority, to record the Trademark Assignment and to issue any and all registrations relating to the Trademarks to and in the name of Assignee.

(iii) **Further Assurances and Cooperation.** As requested by Assignee after the Effective Date of this Trademark Assignment, Assignor shall execute and deliver to Assignee such instruments of transfer and other instruments, such as documents concerning the registration of the Trademarks and any and all certificates of registration, as may be reasonably requested by Assignee in order to vest in Assignee good and marketable title in and to the Trademarks and otherwise in order to carry out the purpose and intent of this Trademark Assignment. Following the Effective Date, Assignor will not object, or assist others in objecting,

to the Assignee's use, registration or attempt to register any mark, slogan, trade name, company name, or domain name containing the Trademarks, in any jurisdiction.

(iv) **Governing Law.** This Agreement shall be governed by and construed in accordance with the laws of California without regard to conflict of laws principles, provided, however, that any and all disputes, controversies, and claims pertaining to Assignor's ownership of or the validity of the Trademark or any registration application for registration thereof shall be governed by and construed in accordance with the federal trademark and related laws, statutes, rules, and regulations of the United States, unless there are no federal laws, statutes, rules, or regulations dispositive of such disputes, controversies, and claims, in which case any and all such disputes, controversies, and claims shall be governed by and construed in accordance with the laws of California without regard to conflict of laws principles.
