**REQUEST FOR RECONSIDERATION DENIED**

The trademark examining attorney has carefully reviewed applicant's request for reconsideration and is denying the request for the reasons stated below. See 37 C.F.R. §2.63(b)(3); TMEP §§715.03(a)(ii)(B), 715.04(a). The following requirement and/or refusal made final in the Office action dated April 28, 2016, is maintained and continues to be final: specimen showing the mark used in commerce in connection with the services. See TMEP §§715.03(a)(ii)(B), 715.04(a).

In the present case, applicant's request for reconsideration does not include a specimen showing the mark used in connection with the services. The brochure submitted with the request discusses a physical product and not a service. Applicant contends that the brochure mentions a "variety of formation testing" and therefore it should suffice as showing the mark used in connection with the consulting services. However, the brochure discusses how the probe is used in testing; it does not show a direct association of the mark with consulting services. Moreover, applicant did not verify the substitute specimen as required by 37 C.F.R. §2.59.

Accordingly, the request is denied. The Board will be notified to resume the appeal. See TMEP §715.04(a).
