REQUEST FOR RECONSIDERATION

Dear Commissioner:

In response to the Office Action of June 2, 2017, Applicant responds as follows:

THE APPLICATION SHOULD BE PASSED TO PUBLICATION

I. THE ANAHEIM PORTION OF APPLICANT'S MARK IS NOT PRIMARILY GEOGRAPHICALLY DESCRIPTIVE

The Examining Attorney has issued a final requirement to disclaim the word ANAHEIM in Applicant's mark ANAHEIM HILLBILLIES on the ground that ANAHEIM is primarily geographically descriptive of the origin of Applicant's goods, namely, "clothing, namely, aprons, bandanas, beach cover-ups, bolo ties, cardigans, culottes, do rags, dresses, infantwear, jackets, jeans, jerseys, leggings, lingerie, loungewear, neckwear, overalls, overcoats, pants, ponchos, rainwear, robes, sarongs, sashes, scarves, shawls, shirts, shorts, skirts, skiwear, sleepwear, socks, surf wear, __

suspenders, sweat bands, sweaters, sweatpants, sweatshirts, swimwear, tank tops, track pants, t-shirts, undergarments, and vests, belts; footwear; and headwear" in Class 25.

More specifically, the Examining Attorney states that:

Applicant must disclaim the wording "ANAHEIM" because it is primarily geographically descriptive of the origin of applicant's goods and/or services, and thus is an unregistrable component of the mark. See 15 U.S.C. §§1052(e)(2), 1056(a); In re Societe Generale des Eaux Minerales de Vittel S.A., 824 F.2d 957, 959, 3 USPQ2d 1450, 1451-52 (Fed. Cir. 1987); In re Joint-Stock Co. "Baik", 80 USPQ2d 1305, 1309 (TTAB 2006); TMEP §§1210.01(a), 1210.06(a), 1213.03(a).

The wording ANAHEIM is a generally known geographic place or location. See TMEP §§1210.02 et seq. The goods and/or services for which applicant seeks registration originate in this geographic place or location as shown by applicant's address in Los Angeles, in which Anaheim is considered a part of the general Los Angeles area. See TMEP §1210.03. Purchasers are likely to believe the goods and/or services originate in this geographic place or location because applicant is located in the greater area of Los Angeles, which encompasses ANAHEIM for all practical purposes. See TMEP §§1210.04 et seq.

(Office Action at 2.) Applicant requests that the Examining Attorney reconsider the refusal to register because the term ANAHEIM, as used in Applicant's composite mark ANAHEIM HILLBILLIES, is <u>not</u> primarily geographically descriptive of the goods.

In order to establish a *prima facie* case for the disclaimer of ANAHEIM in Applicant's mark ANAHEIM HILLBILLIES as primarily geographically descriptive, the Examining Attorney <u>must establish all</u> of the following elements: (1) the primary significance of the mark is a generally known geographic location (TMEP § 1210.02); (2) Applicant's goods originate in the place identified in the mark (TMEP § 1210.03); <u>and</u> (3) purchasers would be likely to believe that Applicant's goods originate in Anaheim, California. (TMEP § 1210.04.) Applicant respectfully submits that the Examining Attorney has not sufficiently established these three elements.

A. The Primary Significance of the Term ANAHEIM is Not a Generally Known Geographic Location

Applicant acknowledges that Anaheim is a city located in California. However, the evidence of record does not establish that the term "Anaheim" is "known generally to the relevant American public" as a geographic location. See In re Newbridge Cutlery, 113 USPQ2d 1445, 1450 (Fed. Cir. 2015). The sole evidence of record consists of two articles making reference to Anaheim as the location of the amusement park Disneyland. The Examining Attorney attached a Google® search printout of a short "Quick Facts" paragraph about Anaheim and a printout of an online article from The Columbia Gazetteer of the World about Los Angeles. The Google® search printout states in part that, "Anaheim is a city outside Los Angeles, in Southern California. It's home to the Disneyland Resort, a massive complex of family-friendly, Disney-themed rides, restaurants, hotels and shops." The only reference to "Anaheim" in the Columbia Gazetteer article is the statement, "Other attractions in the region include the Santa Anita and Hollywood Park racetracks, Knott's Berry Farm, and Disneyland (at Anaheim)."

In short, the Examining Attorney's evidence does not establish the first element of the test. In re Consolidated Foods Corp. 218 USPQ 184, 186 (TTAB 1983) (refusal to register based upon disclaimer requirement reversed - - LAUDERDALE held not primarily geographically descriptive of meats and poultry from Lauderdale County, Alabama because no evidence of public association of term LAUDERDALE with such goods in the record). At most, the American public might be familiar with Orange County, which is a county south of Los Angeles County in Southern California.

B. There is No Goods/Place Association Between the Term ANAHEIM and Applicant's Goods

The Examining Attorney has erred by concluding that, "[t]he goods and/or services for which applicant seeks registration originate in this geographic place or

location as shown by applicant's address in Los Angeles, in which Anaheim is considered a part of the general Los Angeles area." (Office Action at 2.)

Anaheim is *not* part of the city of Los Angeles. The Google® search printout attached by the Examining Attorney supports this. Specifically, the Google search states that, "Anaheim is a city *outside* Los Angeles, in Southern California." (emphasis added.) Anaheim is a city in Orange County, which has distinct geographic, social or cultural differences from Los Angeles. Attached hereto as **Exhibit A** is a printout from the website Ais a printout from the website Things You Need to Explain to Out-Of-Towners About OC". Attached hereto as **Exhibit B** is a printout from the website <oyster.com>titled, "Orange County, California Travel Guide". Attached hereto as **Exhibit C** is a news article from *The Los Angeles Times* titled, "L.A. vs O.C.: Just How Different Are They, Anyway? Now the Truth Can Be Told".

More importantly, the Examining Attorney has proffered no evidence that Anaheim is commonly known to the American public for clothing, headwear, or footwear. The evidence for this application does not point to a goods/place association between Applicant's goods and the ANAHEIM element of Applicant's composite mark. The Examining Attorney only offered the conclusory statement that, "[p]urchasing clothing goods is one of the biggest sellers for Los Angeles purveyors, and the applicant is using that geographic indication as such." Even if that were true of the city of Los Angeles, it is irrelevant to the issue of whether the city of **Anaheim** is commonly known to the American public as a location for clothing, headwear or footwear. If RODEO DRIVE was not considered associated with perfumes, SUNSET BOULEVARD with cologne, nor VENICE MAID with food, then ANAHEIM HILLBILLIES cannot be associated with clothing, headwear or footwear even if as a city it "could, conceivably, be the source of a wide range of goods" including clothing. In re Venice Maid Co., Inc., 222 USPQ 618, 619 (TTAB 1984) (VENICE MAID held not primarily geographically deceptively misdescriptive of canned foods, including lasagna and spaghetti, where the

evidence of a goods/place association was found insufficient; the Board stated, "we are unwilling to sustain the refusal to register in this case simply on the basis that Venice is a large Italian city that could, conceivably, be the source of a wide range of goods, including canned foods"). Thus, there is no goods/place association and the Examining Attorney has proffered no evidence to the contrary.

Applicant reiterates that Applicant's mark ANAHEIM HILLBILLIES is a composite mark. As such, the Examining Attorney must determine the primary significance of the composite. TMEP § 1210.02(c). If, when viewed as a whole, a composite mark is not likely to be perceived as identifying the geographic origin of the goods or services (i.e., the mark is not primarily geographically descriptive), the mark is regarded as arbitrary, fanciful or suggestive. TMEP § 1210.02(c)(iii). Such is the case here. The words "Anaheim" and "Hillbillies" do not connote anything about clothing, headwear, or footwear. The word "Anaheim" at best identifies the general location of theme parks in Southern California. The word "Hillbillies" connotes an unsophisticated person from a rural area. See infra. As such, the combination is arbitrary when used to identify clothing, headwear, and footwear.

Furthermore, Section 1213.05(d) of the TMEP provides that, "[i]f two or more terms are combined in a mark to create an incongruity (e.g., URBAN SAFARI, MR. MICROWAVE, and DR. GRAMMAR), the mark is unitary and no disclaimer of nondistinctive individual elements is necessary." TMEP §1213.05(d). This should also hold true for marks with geographic terms. In *In re Sharky's Drygoods Co.*, 23 USPQ2d 1061 (TTAB 1992), the Board held that PARIS BEACH CLUB was not geographically deceptively misdescriptive or geographically deceptive of clothing because there was no goods/place association between the city of Paris and clothing:

In this case, Paris is certainly not an obscure or remote geographical term, it being the well-known capital of France. However, the mark in question is not the word "Paris" per se; it is PARIS BEACH CLUB. Paris, of course, is not located on an ocean or lake, and does not have a beach. The juxtaposition of Paris

with Beach Club results in an incongruous phrase, such that purchasers will view PARIS BEACH CLUB as a humorous mark, with the word "Paris" in the mark being a facetious rather than a geographic reference, a take-off on the fact that the city of Paris is known for haute couture. It is Paris' connection with high fashion that is intrinsic to the satire, and makes this take-off on the cachet associated therewith work....We do not believe that the American public will engage in such an extensive analysis of the mark. Consumers, viewing the mark in connection with T-shirts and sweatshirts, will understand it to be a joke, and will not regard it as providing any information as to the nationality of the manufacturer.

In re Sharky's Drygoods Co., 23 USPQ2d at 1062-63.

Applicant's mark ANAHEIM HILLBILLIES falls squarely within the parameters of In re Sharky's Drygoods Co. Applicant's mark ANAHEIM HILLBILLIES is an incongruous phrase. The word "Hillbillies" means "someone who lives in the countryside, especially someone who is not very well educated". Attached hereto as **Exhibit D** is a printout from *MacMillan Dictionary*'s website at <macmillandictionary.com> showing the definition of "hillbilly". The juxtaposition of ANAHEIM and HILLBILLIES is humorous and incongruous because Orange County (which encompasses Anaheim) is a well-populated urban region that includes a generally affluent and well-educated population. See Exhibits A-C. One would not expect to find "hillbillies" in Orange County or Anaheim. The relevant consumers for Applicant's clothing, headwear and footwear will understand ANAHEIM HILLBILLIES to be a humorous joke, just as the relevant consumers for the applicant's clothing in In re Sharky's Drygoods found PARIS BEACH CLUB to be a humorous joke. The gothic and ornate font style of Applicant's mark emphasizes the ironical humor in Applicant's mark, because "Hillbillies" conjures up an impression of simple country folk, rather than an impression of a medieval or gothic person. Applicant should not be required to disclaim ANAHEIM because of the unitary and incongruous nature of Applicant's composite mark ANAHEIM HILLBILLIES.

C. <u>Purchasers Are Not Likely to Believe that Applicant's Goods Originate in Anaheim, California</u>

Finally, purchasers are unlikely to believe that Applicant's goods originate from a specific geographic location because, as a threshold matter, the general American public is unlikely to recognize "Anaheim" as a geographic location. Even if they do, the city of Anaheim is not known for clothing, headwear or footwear; therefore purchasers are unlikely to believe that Applicant's goods originate in Anaheim. As explained above, the relevant purchasers are instead likely to view Applicant's mark ANAHEIM HILLBILLIES as a humorous, incongruous phrase. The Board has recognized this additional layer of meaning in other geographic marks that comprise a geographic term with a type of person. Attached hereto as Exhibit E is a copy of the registration certificate, TESS printout and TSDR printout for Reg. No. 347,081 for the mark VIRGINIA GENTLEMAN (Stylized) for whiskey, wherein "Virginia" is not disclaimed. Attached hereto as Exhibit F is a copy of the registration certificate, TESS printout and TSDR printout for Reg. No. 383,848 for the mark DUTCH BOY (Stylized) for paint and varnish brushes, wherein "Dutch" is not disclaimed. Attached hereto as Exhibit G is a copy of the registration certificate, TESS printout and TSDR printout for Reg. No. 1,269,348 for the mark AMERICAN GIRL for skirts, jumpers, pants and blouses, wherein "American" in not disclaimed. Just like these other marks, Applicant's mark ANAHEIM HILLBILLIES is a unitary mark, and a disclaimer of ANAHEIM should not be required.

II. CONCLUSION

Based on the foregoing, the Examining Attorney has, respectfully, not met her burden of demonstrating that the ANAHEIM portion of Applicant's composite ANAHEIM HILLBILLIES mark is geographically descriptive. Applicant requests that the Examining Attorney's disclaimer requirement of ANAHEIM be withdrawn and

Applicant's mark be passed to publication. Applicant has filed a Notice of Appeal to the Trademark Trial and Appeal Board herewith.



3. All the TV shows you've seen are bogus



7. That giant glowing hermit crab off the 57 is not a nightclub


It's a train station. And unless you're taking Metrolink in for an Angels or Ducks game, you have no reason to be there.

12. Irvine Lake is not in Irvine






16. GPS is required when traveling through Irvine





L.A. vs O.C. : Just How Different Are They, Anyway? Now the Truth Can Be Told

WHAT IS IT between Los Angeles and Orange counties?

Are we not warmed by the same ultraviolet rays, quenched by the same pirated water, ensnared in the same gill net of freeways? Are our differences really any wider than the line on a gerrymanderer's map?

Let us put it to scholars, men of enlightenment and reason.

Orange County historian Jim Sleeper (with feeling): "I wouldn't go up to Los Angeles to see Jesus Christ rassle a bear."

Los Angeles historian John Weaver (a trifle smugly): "The Irish poet AE (George Russell) said we tend to become the image of the thing we hate. Orange County, of course, has become L.A."

THIS FAMILY FEUD has a long history. In 1889, Orange County--then known as the Santa Ana Valley and resentful at being taken for taxes and then taken for granted--seceded from a Los Angeles County that was nearly as big as Ohio. One hundred and one years later, the first- and third-most-populous counties of the wealthiest and most populous state in America find themselves lashed together by geopolitics, entwined by the luster of riches and land and encumbered by too many humans questing for both: a single coastal and sub-desert domain forged from the same delusion that, here, life could be all things to all people.

Ask any family: There is more relish in fighting at close quarters. You know the other guy so well. So here we are, playing out something from a prime-time soap opera: the mercurial con man older brother versus the anxious-to-please, overachieving younger sibling. Like any siblings, though, they're more alike than they care to admit. They share a common history, a social vocabulary, an obsession with the automobile and, until recently, an almost genetic belief in the virtue of growth.

As the two counties swiftly evolve, sometimes on parallel tracks, sometimes at oblique angles, sometimes in accordance with their own cliches and sometimes in violation of them, they embody two designs for living (and dreaming).

Some of their differences can be quantified. Orange County is wealthier, whiter, with far less violent crime than L.A. County. Nearly half of the L.A. County residents polled last year had recently considered moving away, one out of every dozen naming Orange County as a good place to go. Far more Orange County residents like it where they are, and only six in 1,000 wanted to live in L.A. County. Angelenos do sound grumpier, according to polls conducted for The Times; 42% of L.A. residents were dissatisfied with Southern California in general, compared to 30% in Orange County.

Other differences are matters of custom and style. At its best, Orange County comes across as well-groomed, generous of creature comforts, pretty in a standardized, debutante fashion, in part from master planning that has become a worldwide model. In a 1976 television program on the American Bicentennial, the BBC crowned it "the culmination of the American dream." At its worst, Orange County

appears to be nouveau-riche snobbish, insecure, artificially flavored and colored, vapid, priggish and drearily sanitized. At a Tustin bagel shop, the bestseller is a Pillsbury Bake-Off kind of flavor: cinnamon raisin.

L.A. County, at its best, comes across as urbane, lively, tolerant, expansive, with a sense of humor about itself. What other place can palm off on tourists a huge and hideous sign (HOLLYWOOD) as an icon? It offers the world in miniature, for the world comes to it. Have the kiwi cheesecake at the Cuban bakery for dessert, after a kosher-style burrito or the *mititei* at the Romanian diner, after sitting through a Fellini marathon at a movie revival house fitted out like a Pharaoh's palace. At its worst, L.A. seems to be self-absorbed, deeply segregated for all its ethnic mix, stupefyingly rich and Third World poor, self-congratulatory yet in places as squalid and grimy as any Rust Belt burg, wearyingly obsessed with success, civically inept, a big floundering lummox of a place.

DEBBIE BOHNETT DEPARTED the sweet peaceability of Northern California some months ago to work at the Neiman Marcus in Newport Beach. (It was the first Neiman Marcus in California, and when Neiman Marcus plants its flag in foreign soil, that spot is bound to be as moneyed as the outflow end of an oil pipeline.) In her Bay Area innocence, Bohnett had rather casually taken one Southern California beach town to be indistinguishable from another. Neighbors and colleagues let her know otherwise. "I learned in the first three days not to say you live in L.A. I would be immediately corrected, and it wouldn't be in a joking manner," she says.

During the 1960s, as pioneering Republican political consultant Stu Spencer was trolling for contributions, Orange County's moneyed businessmen would not pull out their checkbooks until they had asked him, " 'How much have those bastards in L.A. given?' They weren't gonna give me a dime until I got the money out of L.A. first."


