**MOTION REQUESTING SUSPENSION OF EX-PARTE APPEAL PROCEEDING AND
CANCELLATION OF SCHEDULED ORAL HEARING**

COMES NOW Appellant, Pan American Properties, Corp. (“Appellant”), by and through its undersigned attorney, and respectfully sets forth and prays as follows:

1. Appellant has an Oral Hearing scheduled for next Tuesday, December 10, 2019, in the referenced Ex-Parte Appeal proceeding, filed for trademark SHAKY, U.S. Serial No. 87147819 in International Class 025.

2. Said mark was refused under Section 2(e)(1) of the Trademark Act, 15 U.S.C. §1052(e)(1), because of an alleged likelihood of confusion with trademark in U. S. Registration No. 4511875 for “SHAKY KNEES”.

3. However, the cited registration has an upcoming deadline for the filing of Section 8, which is due on April 8, 2020.

4. Because of this, and in order to avoid unnecessary time and expenses from this party and the Board, Appellant very respectfully requests that the Oral Hearing

scheduled for December 10, 2020 be cancelled, and that the proceedings be suspended pending the disposition of the mark in U. S. Registration No. 4511875 for “SHAKY KNEES¹”.
