APPLICANT’S REQUEST FOR EXTENSION OF TIME TO FILE APPEAL BRIEF

Applicant, Tomorrow Sleep LLC (“Applicant”), by its attorney, hereby moves to extend the deadline of July 17, 2018 for it to submit an appeal brief in the above-referenced matter. This is Applicant’s first extension request in this matter. Applicant acknowledges that this request is five (5) business days past the initial appeal brief deadline. Applicant apologizes for the delay, which was inadvertent, and respectfully requests that the Board review and grant this requested extension.

TBMP § 1203.02(d) provides that an extension of time to file Applicant’s appeal brief can be granted by the Board upon written request showing good cause for the extension. TBMP § 1203.02(d) states that good cause could include attempting to negotiate an agreement. Applicant respectfully submits that good cause exists for this extension because it is attempting to negotiate an agreement with the owner of cited U.S. Registration No. 5024526.

In Applicant’s attorney’s experience, the Board has granted extensions under these circumstances for 60 days. However, Applicant anticipates that negotiations could exceed this time period. Applicant therefore requests an extension of time for 120 days until **November 14, 2018**. If the Board is not willing to grant an extension of this length of time, Applicant respectfully requests that the Board grant an extension of 60 days or 90 days instead.
