**REQUEST FOR 60-DAY EXTENSION OF TIME TO FILE MAIN APPEAL BRIEF
IN EX PARTE APPEAL**

DMS Apex Holdings LLC (“Applicant”) respectfully seeks a sixty (60) day extension of time to file its main appeal brief in the above-referenced *ex parte* appeal. **Applicant’s current deadline is November 1, 2019.**

Applicant seeks this extension because Applicant is still reviewing the facts in this dispute and needs additional time to investigate whether it will be possible to resolve this dispute via a different approach that is potentially less expensive or more expeditious (for example, third-party agreements that would potentially resolve the remaining issues). Applicant is also actively considering its procedural options in this regard. Applicant does not seek this extension for purposes of delay or any other purpose that would not justify the extension, and instead, Applicant seeks this extension in the interests of judicial economy and for the other reasons referenced above.

This is the third extension of time that Applicant has sought in this appeal, and given the totality of circumstances, Applicant respectfully submits that a 60-day extension of its current deadline is reasonable. Applicant also respectfully submits that this extension request accords with Section 1203.02(d) of the *Trademark Board Manual of Procedure* (TBMP), and there is sufficient good cause for the granting of this extension. *See* TBMP 1203.02(d) (“An extension of time for filing an appeal brief in an *ex parte* appeal to the Board may be granted by the Board upon written request showing good cause for the requested extension. The determination of good cause will be based upon all relevant circumstances, including the length of time of any previously granted extensions and the reason(s) for the requested extension(s)”).

Applicant thanks the Board for its time and consideration.
