I. INTRODUCTION

Applicant TLJ Capital Group, LLC("Applicant") hereby submits this response to the December 20, 2018 Final Office Action from Examining Attorney John Sullivan ("Trademark Examiner") refusing to register the Mark, "POOCHES PARADISE", Serial Number 87/584,100 (hereinafter "the Applied-For-Mark").

The Trademark Examiner objects to registration of the Applied-For-Mark on the ground that, pursuant to Section 2(d), it purportedly is confusingly similar to marks held by the same owner, Registration Nos. 3,037,646; 4,271,371; and 4,271,373 ("Cited Marks"). Applicant respectfully disagrees with the Section 2(d) objection for the reasons discussed immediately below.

Applicant has presented its arguments that there is no likelihood of confusion because when all of the relevant *DuPont* factors are considered, the analysis is in favor of registration. *Plus Products v. Plus Discount Foods, Inc.*, 722 F. 2d 999, 1004 (2d Cir. 1983) (applying the Second Circuit's equivalent test under *Polaroid Corp. v. Polaroid Electronics Corp.*, 287 F.2d 492 (2d. Cir. 1961)); McCarthy on Trademarks and Unfair Competition § 24:43 (Fifth Ed. 2017). No single factor is determinative; "each must be considered in the context of all the other factors." *Plus*

Products, 722 F.2d at 1004. Applicant argues that there is no confusion because there are differences in the conditions at purchase, pet owners are discriminating and make careful decisions concerning the care of their pets so as to dispel any likely confusion, the Cited Marks are weak due to the volume of "paradise" uses in the relevant space, the marks are dissimilar, and Applicant's Mark and the Cited Mark have co-existed without confusion.

The Examiner states that it was unpersuaded because it has no proof that pet owners are careful in considering where they are boarding their pets (thereby refuting application of the discriminating purchaser standard), and Applicant did not submit evidence that the Cited Marks are entitled to a narrow scope of protection due to the volume of similar uses of "paradise" marks. Applicant incorporates its response to the non-final office action herein, and further responds as follows.

Applicant argues that pet owners are particularly attentive in selecting services for their family pets, and thus are likely to readily recognize the differences between the Applied-for-Mark, POOCHES PARADISE, and the services associated there-with, and the Cited Marks. *Cohn v. Petsmart, Inc.*, 281 F.3d 837, 843 (9th Cir. 2002) ("...[P]et owners should be particularly attentive in selecting a veterinarian for their family pets, and thus are likely to perceive the differences between [Plaintiff's] veterinary clinic and [the Defendant].).

Importantly, it follows that any pet parent who cares enough to obtain Applicant (or Registrant's) services is someone that is careful in looking at the particular source of the services, and associated offerings. Applicant is unsure of exactly what it could submit to show that parents are careful in the selection of services for their pets but rasserts that this conclusion is valid on its face. Moreover, given the volume of options, pet parents must be careful and discriminating. Applicant has located no less than the following websites that offer services in the same or similar

space as Registrant, all of which use the word element "PARADISE", some of which use a mark identical to Registrant, and none of which are Registrant:

- Paws Inn Paradise (<u>www.pawsinnparadise.com</u>)

In light of the market realities, Applicant seeks to register its mark, POOCHES PARADISE, and have the ability to protect its mark under federal law. Applicant recognizes the strength and somewhat limited breadth of the Applied-for-Mark, even when registration is granted, given the number of establishments in the market that offer similar services.

Examiner's refusal is tantamount to giving Registrant a monopoly over the field whereby the service provider uses the word element "pet" and uses the word element "paradise". Registrant is not entitled to, and in fact does not have, ownership of all "paradise"-containing trademarks in this space. Registrant recognizes as much as it has not policed use of its identical mark in the same space (as many of the above websites have been in existence for years).

Importantly, this speaks to the requirement that pet parents must be careful, and are discriminating in seeking the services they desire for their pet. The First Circuit has reasoned that the sophistication of consumers is perhaps the "most critical factor" in the likelihood of confusion analysis because well-trained and focused consumers are highly unlikely to mistake one party's product for another. *Astra Pharm. Prods., Inc. v. Beckman Instruments, Inc.*, 718 F.2d 1201, 1206 (1st Cir. 1983). The elevated "discriminating purchaser" standard is the appropriate standard in this case. The services offered in association with the Mark are not "impulse" purchases. Rather, the dog-care services offered by Applicant are only purchased after a careful search, likely involving background research, to find the optimal experience for the family dog. The services offered under the Cited Marks do not appear to be limited to dogs, but nevertheless, customers who ultimately seek the services associated with the Cited Marks for the family pet are equally discriminating. Applicant's target market is comprised of focused, sophisticated and purposeful shoppers who are looking for particular services. Consequently, these consumers are highly unlikely to become confused.

Applicant further argues, and Examiner is silent on, the fact that while both the Applied-for-Mark and the Cited Marks use the word element "Paradise", the services offered by each are not sold by verbal order. As such, confusion is not likely. *Cf. Krim-Ko Corp. v. Coca-Cola Bottling Company of New York*, 390 F.2d 728, 731-32 (USCCPA 1968). While it may not be a

single determinative factor, the method of ordering or purchasing a product is a relevant consideration to how consumers or potential consumers might perceive a mark.

While the Examiner was not persuaded by the fact that Applicant's Applied-for-Mark and the Cited Marks have coexisted without actual confusion for over ten years, Applicant further notes that there has also been no confusion amongst the several common law marks aswell. The absence of confusion is strong evidence favoring registration of Applicant's Mark. See Plus Products, 722 F.2d at 1006; Pignons S.A. de Mecanique de Precision, 657 F.2d at 490.

Applicant has further argued that the Trademark Office has allowed hundreds of third-party registrations utilizing the word elements contained in the Cited Marks, "Pet" or "Paradise," many in the same or related International Class as the Cited Marks (classes 41, 43 and 44). The Applied-for-Mark does include the word element "Pooches" which is intended to be suggestive of "dogs". The Trademark Examiner's position that the mere use of the word elements "Pooches" and "Paradise" will lend to confusion is tantamount to giving unduly broad protection to the Cited Marks, despite the crowd of registrations that contain the same or similar word elements.

Evidence that the consuming public is exposed to third-party uses of similar (or identical) marks on similar goods/services "is relevant to show that a mark is relatively weak and entitled to only a narrow scope of protection." *Palm Bay Imps., Inc. v. Veuve Clicquot Ponsardin Maison Fondee en 1772*, 73 U.S.P.Q.2d 1689, 1693 (Fed. Cir. 2005); *see also* TMEP § 1207.01(d)(iii). A portion of a mark may be weak if it is in common use by third parties. *See Colgate-Palmolive Co. v. Carter-Wallace, Inc.*, 432 F.2d 1400, 167 U.S.P.Q. 529 (C.C.P.A. 1970). The number and nature of similar marks in use on similar services has a significant impact on the strength of a

¹ Based upon the registration of the Cited Marks, the parties have coexisted for over a decade (10 years). The Applicant has been using the Applied-for-Mark since at least 2005. The Cited Marks have been in use since at least 2007 (once since 2002).

mark. See Loyds' Food Prods., Inc. v. Eli's, Inc., 987 F.2d 716, 768 (Fed. Cir. 1993). "Evidence of widespread third-party use, in a particular field, of marks containing a certain shared term is competent to suggest that purchasers have been conditioned to look to other elements of the marks as a means of distinguishing the source of goods or services in the field." In re Broadway Chicken, Inc., 38 U.S.P.Q.2d 1559 (T.T.A.B. 1996); see also TMEP § 1207.01(d)(iii).

Because of the meaningful differences between the parties' marks and because of the sophistication and discernment of the consumer of the services offered in connection with these marks, it is unlikely that customers will be confused between the services offered by the parties. In other words, as a result of the large number of third-party registrations and uses of "pet" and "paradise", and particularly in light of the sophistication and discerning nature of pet parents, as discussed above, the public is presumed to be readily capable of distinguishing between marks incorporating the terms based on even slight differences. *See First Sav. Bank, F.S.B. v. First Bank System, Inc.*, 101 F.3d 645, 653-55, 40 U.S.P.Q.2d 1865 (10th Cir. 1996) ("When the primary term is weakly protected to begin with, minor alterations may effectively negate any confusing similarity between the two marks"); *General Mills, Inc., supra*, 824 F.2d at 626 ("Determining that a mark is weak means that consumer confusion has been found unlikely because the mark's components are so widely used that the public can easily distinguish slight differences in the marks, even if the goods are related"). The visual differences between the Applied-for-Mark and the Cited Marks only further bolsters the lack of a likelihood of confusion.

Applicant has further argued, and maintains that the overall consumer/commercial impression of Applicant's Mark and the Cited Marks is different. Phonetically, the Applied-for-Mark stands out for its length and suggestiveness. The word element "POOCHES" as used in the Applied-for-Mark is longer than the word element in the Cited Marks, "Pet". Further, the word element

"POOCHES" is argued by Applicant to be suggestive of a dog, while the word element "Pet" is attributable to all domestic animals, not just dogs. The Cited Mark consisting of a design, Registration Number 4,271,371, has even less risk of confusion with the Applied-for-Mark. The overall marketplace perception would differ greatly here, factoring in color scheme, font, layout, and the distinct design features of this Cited Mark relative to the standard characters of the Applied-for-Mark. . *See Gruner + Jahr USA Publishing v. Meredith Corp.*, 991 F.2d 1072, 1078, 26 U.S.P.Q.2d 1583 (2nd Cir. 1993). The Applied-for-Mark appears in standard character block lettering while this Cited Mark has lower-case lettering. This Cited Mark consists of the silhouette drawing of the front view of a sitting dog with its nose pointed up, wearing a collar, and no visible tail. The Applied-for-Mark has no design. The visual impact of these marks is starkly different because these marks are different.

This Cited Mark is also used in connection with a tagline, which reduces or outright eliminates any likelihood of confusion. *Cohn*, 281 F.3d at 842 (citing 3 J. Thomas McCarthy, *McCarthy on Trademarks and Unfair Competition § 23:47* (4th ed. 1997)). The tagline used with this Cited Mark is "paradise for pets." The Applied-for-Mark has no tagline. Consequently, the considerable differences between the Applied-for-Mark and the Cited Marks, in sight, sound and overall commercial impression, further dispel any potential for consumer confusion. This conclusion is further supported by the sophisticated and discerning nature of the target market for the services provided in connection with the Applied-for-Mark.

III. CONCLUSION

For the foregoing reasons, stated herein and in the initial response to Office Action, Applicant respectfully requests that Examiner withdraw its refusal and that the Mark be permitted to proceed to publication.





The system sends out the email a month before the vaccine expires, so that if you do have an upcoming appointment, you have enough time to get that vaccine updated and don't have to worry about it last minute. We have also been sending out birthday wishes to your lovely pets in which the email states your pup gets a free day of doggy daycare on us! No need to make a reservation for it, just show us the email when you drop off and we will apply the birthday coupon.

As summer winds down and you try to fit in one more getaway weekend, make sure to reserve a spot for your pet, as we are filling up fast for the last couple weekends of summer. And as they say, its never too early to start thinking about the holidays. We operate similar to a hotel. Check in is anytime during regular business hours on the day of arrival. Effective January 1, 2018, your pet will need to picked up by Noon on the day of departure so that we may have time to prepare for incoming guests. If you cannot arrange for him/her to be picked up by then, we will slot them in our daycare program. You will be charged for ½ day of daycare up until 6pm. The current fee will be \$12.50 per pet. In the event that your pet has



not checked out and we need the room for another guest, we may remove your dog from his/her room and relocate them in a play area, etc. while they wait to be picked up. If your pet is not picked up by 6pm then the overnight rate will apply. Please note: You will need to make arrangements in advance if you will be having someone other than yourself picking up your pet. We will not release a pet to anyone else unless we have the proper authorization forms filled out

Keep in mind, you are always charged for Sundays...it is the same price whether you check out on Sunday or Monday by noon. Some see this as a 2-day weekend minimum stay.

Requirements in the First Ten Years* What and When to File:

First Filing Deadline: You must file a Declaration of Use (or Excusable Nonuse) between the 5th and 6th years after the registration date. See 15 U.S.C. §§1058, 1141k. If the declaration is accepted, the registration will continue in force for the remainder of the ten-year period, calculated from the registration date, unless cancelled by an order of the Commissioner for Trademarks or a federal court.

Second Filing Deadline: You must file a Declaration of Use (or Excusable Nonuse) and an Application for Renewal between the 9th and 10th years after the registration date.*

Requirements in Successive Ten-Year Periods* What and When to File:

You must file a Declaration of Use (or Excusable Nonnse) and an Application for Renewal between every 9th and 10th-year period, calculated from the registration date.*

The United States Patent and Trademark Office (USPTO) will NOT send you any future notice or reminder of these filing requirements.

*ATTENTION MADRID PROTOCOL REGISTRANTS: The holder of an international registration with an extension of protection to the United States under the Madrid Protocol must timely file the Declarations of Use (or Excusable Nonuse) referenced above directly with the USPTO. The time periods for filing are based on the U.S. registration date (not the international registration date).
