**APPLICANT'S MOTION FOR EXTENSION OF TIME TO FILE TRIAL BRIEF**

Applicant Ignite Team Partners, LLC hereby requests and extension of time to file her trial brief, and support thereof, states as follows:

1. Applicant's trial brief is due to be filed on or before Monday, December 21, 2020.
2. Applicant is currently in discussions with Elevation Consultants, LLC, the owner of the two registrations for IGNITE TREATMENT CENTERS, Reg. No. 5584815 (standard character) and 5586231 (with design), that were the basis of the Examining Attorney's final refusal dated April 1, 2020, and the Examining Attorney's denial of the request for reconsideration, dated October 20, 2020.
3. Elevation Consultants has indicated that it is amenable to entering into a co-existence agreement with Applicant, but Applicant and Elevation Consultants need more time to finalize that agreement. That co-existence agreement, if acceptable to the Examining Attorney, would end the need for this appeal.
4. This is Applicant's first motion for an extension of time in which to file its brief.

Applicant Ignite Team Partners, LLC therefore requests that the time for filing of its trial brief be extended by 60 days, or to February 18, 2021.
