**REQUEST TO REMAND AND AMEND IDENTIFICATION OF GOODS**

Applicant hereby requests that Application Serial No. 88324332 for the mark ARABEE & Design be remanded to the Examining Attorney and amended as proposed by the Examining Attorney in the Reconsideration Letter mailed April 3, 2021. Specifically, Applicant seeks amendment of the identification of services in International Class 41 to the exact language proposed as acceptable by the Examining Attorney in the April 3, 2021 Letter, namely:

International Class 041: Education, namely, providing classes and instruction in the field of the Arabic language; provision of training in the field of foreign languages, namely, Arabic; entertainment, namely, providing online non-downloadable education materials and content in the nature of videos, songs, music, interactive online teaching **COMPUTER** games, printable worksheets, teacher guides, language **INSTRUCTION MANUALS** ~~rubric~~, ~~web-based applications~~, audio, cartoons, comic books, **PHOTOGRAPHIC** images, graphics **WORKS**, online dictionaries, online **TRANSLATION DICTIONARIES** ~~translators~~, electronic publications, **IN THE NATURE OF** electronic books, electronic textbooks, electronic magazines, and movies, **ALL OF THE FOREGOING** to assist in learning Arabic; entertainment, namely, organizing and conducting events and activities in the nature of educational **FOREIGN LANGUAGE INSTRUCTION** club ~~S~~ ~~services~~, workshops, cultural and arts events, social entertainment events and educational competitions to assist in the teaching and

learning of Arabic; cultural activities, namely, arranging and conducting cultural events and shows which relate to the Arabic language and culture; **ENTERTAINMENT, NAMELY, PROVIDING ONLINE NON-DOWNLOADABLE EDUCATION MATERIALS AND CONTENT IN THE NATURE OF PROVIDING TEMPORARY USE OF A NON-DOWNLOADABLE WEB APPLICATION FEATURING COMPUTER GAMES TO ASSIST IN LEARNING ARABIC**

In support of its request, Applicant notes that this amendment would fully resolve all outstanding issues with this application and put it in condition for allowance. However, because the Examining Attorney no longer has jurisdiction to act on this requested further amendment, Applicant respectfully requests that the Trademark Trial and Appeal Board remand the application to the Examining Attorney, so that she can amend the application as indicated above. Applicant notes that its time to file its appeal brief in this matter has not yet expired, and no brief has been filed.
