Objection to Further Extensions of Time to Oppose

Pursuant to Title 11, Division 1, Chapter 4, Section 312 of California Regulations on the Supervision of Trustees and Fundraisers for Charitable Purposes the organization granted an extension of time to oppose, MISS BARSTOW PAGEANT, INC., 34173 WESTERN DRIVE BARSTOW, CA 92311, UNITED STATES, had a delinquent status in their charity filing status with the California Attorney General's office at the time of Kaitelyne Blackwood's California service mark application. This organization had been delinquent since 2008 when Kaitelyne Blackwood began applications for her California service marks and is not listed at the address listed in the opposition request. At the time of their delinquency, Kaitelyne Blackwood, obtained the following service marks in the state of California, MISS BARSTOW and TEEN MISS BARSTOW. After gaining ownership of the aforementioned California service marks on July 29, 2020 Kaitelyne Blackwood was in the process of applying for the federal trademark. Upon research Kaitelyne Blackwood discovered MISS BARSTOW PAGEANT, INC., applied for and was denied a federal trademark, serial number 90052740. This trademark was applied for on July 14, 2020. MISS BARSTOW PAGEANT, INC. was given noticed of their denied trademark on August 12, 2020 and thus Kaitelyne Blackwood finished her trademark application MISS BARSTOW on September 13, 2020. After application, review and notice of publication Kaitelyne Blackwood received no notice from MISS BARSTOW PAGEANT, INC. that they had any inclination to reapply for their federal trademark. With this being said the organization should not be granted their 90 day request for extension.
