
CHANGE OF ADDRESS AND MOTION FOR WITHDRAWAL OF ATTORNEY





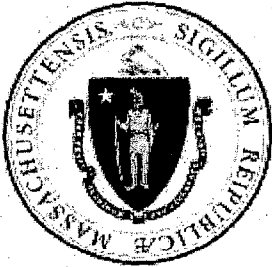
