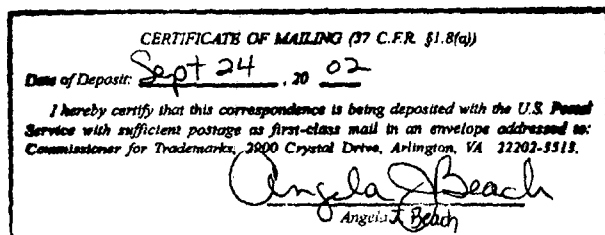
The above application and oppositions are withdrawn according to a License Agreement between the parties, entered into on September 14, 2002, settling the above-referenced matters.
