Attached for your consideration are the following documents:

We note also that the Consented to Motion to Accept Late-Filed Answer was in fact received by the PTO, and therefore it appears that the other papers became disassociated after receipt by the PTO.

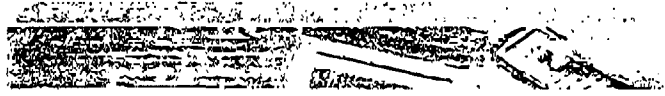
