REQUEST OF WILMER CUTLER PICKERING HALE AND DORR LLP TO
WITHDRAW AS ATTORNEY OF RECORD FOR INTELLIGROUP, INC.

Pursuant to 37 C.F.R. §2.19 and 37 C.F.R. §10.40(c), Wilmer Cutler Pickering Hale and Dorr LLP ("Wilmer Hale"), respectfully requests permission to withdraw as attorney of record for Intelligroup Inc. in the above-identified trademark opposition matter.

As grounds for this request, Wilmer Hale asserts that it has tried to reach Christian Misvaer, General Counsel for Intelligroup Inc., several times since November, 2004 for instructions on how to proceed in the opposition. Mr. Misvaer has failed to respond to Wilmer Hale's correspondence and voice mail messages. As a result of Mr. Misvaer's failure to respond to Wilmer Hale, it is impossible for Wilmer Hale to effectively carry out its representation of Intelligroup Inc.



In a letter dated July 6, 2005 (a copy of which is attached as Exhibit A) Sally Byrne of Wilmer Hale advised Mr. Misvaer that if Wilmer Hale did not hear from Mr. Misvaer by July 13, 2005, it would file a request with the Trademark Trial and Appeal Board to withdraw as attorney of record in this case. Wilmer Hale has not received a response to that letter. The letter was sent to Mr. Misvaer by facsimile and by certified mail, return receipt requested. Attached as Exhibit B is a copy of the fax confirmation sheet indicating that the fax was transmitted on July 6, 2005. Wilmer Hale has not received the return receipt requested with the certified mailing. The Postal Service has advised Wilmer Hale that an item matching the receipt number of Wilmer Hale's certified letter was delivered to the Post Office in Edison, New Jersey (the city in which Intelligroup is located) on July 8, 2005 and that that item has not been picked up by the addressee.

In light of the foregoing, Wilmer Hale respectfully submits that it cannot effectively represent Intelligroup, Inc. in this opposition. Accordingly, Wilmer Hale respectfully requests that the Board grant its motion to withdraw as attorney of record for Intelligroup, Inc. in this opposition.


