
**PETITIONER/OPPOSER'S MOTION FOR EXTENSION OF TIME
TO FILE REPLY MEMORANDA**

Petitioner/Opposer, Estefan Enterprises, Inc. ("EEI"), pursuant to T.M.B.P. § 528.02, requests an extension of time, through and including November 30, 2005, to file its Reply Memoranda in support of EEI's Motion for Summary Judgment and Supplement to Motion for Summary Judgment ("Reply Memoranda") in the Cancellation Proceeding. In support thereof, EEI states as follows:

On October 27, 2005, EEI filed a motion for an indefinite extension of time to file its Motion for Summary Judgment in the opposition proceeding and Reply Memoranda due to the effects of Hurricane Wilma which left undersigned counsel and EEI without power, severely hampering their ability to conduct business. In that motion, EEI stated it would inform the Board the specified amount of additional time required once EEI's power has been restored. Once EEI's power was restored, EEI requested an extension of time, through and including November 23, 2005, to file its Motion for Summary Judgment and Reply Motion for Summary Judgment. EEI's Response to


