MOTION TO EXTEND DISCOVERY AND TRIAL PERIODS

On or about August 13, 2001, opposer, Internet Superbrand, Inc. (“ISI” or “Opposer”), a California corporation with a business address of 7545 Irvine Center Drive, Irvine, California 92618, opposed the registration of the mark POPOPEDIA, that is the subject of application Serial No. 76/100,398, filed with the USPTO on August 1, 2000.

On or about February 25, 2002, the TTAB issued a discovery and briefing schedule in this matter, and ordered applicant to answer ISI’s opposition within 40 days after February 25.




