Opposer's 30-Day Rebuttal Testimony Period To Close: October 14, 2003


The parties respectfully request that the Board approve this stipulation and the above-referenced extensions of the discovery and trial dates.

This Stipulation is submitted by counsel for Applicant, but the Opposer, HSBC Holdings, has stipulated, through counsel, to the above terms.




