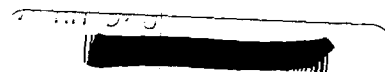


discussions, it would be in the best interest of both parties to suspend further work on these proceedings.


