

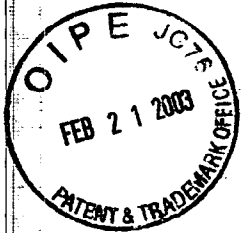

**MOTION ON CONSENT TO EXTEND THE TIME
TO ANSWER THE NOTICE OF OPPOSITION AND TO
RE-SET THE DISCOVERY PERIOD AND SUBSEQUENT
TRIAL DATES AND BRIEFING PERIODS**

Testimony period for party in Position of defendant to close	January 31, 2004
Rebuttal testimony period to Close	March 17, 2004

Briefs shall be filed in accordance with Rule 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Rule 2.129.
