Opposer Hilti Aktiengesellschaft and Opposer Hilti, Inc. ("Opposer"), related companies, and Applicant Milwaukee Electric Tool Corporation ("Applicant") hereby jointly request the Board to suspend the above-identified opposition proceeding pending consolidation of four

additional opposition proceedings, all of which involve the same or related parties, as well as common questions of law or fact.


Currently, Applicant has nine (9) pending applications to register designs consisting of a predominantly red with gray and/or black accents color scheme (the “Color Combination Mark”) for electric power tools. Opposer, Hilti, Inc. and Opposer Hilti Aktiengesellschaft have filed a Notice of Opposition against each of these applications, totaling eighteen (18) opposition proceedings, of which fourteen (14) have been instituted and consolidated under Opposition No. 153,234.

The remaining four opposition proceedings have recently been instituted and Applicant has filed its Answer in each proceeding. Opposer and Applicant have requested that the Board consolidate these last four opposition proceedings with the fourteen consolidated proceedings under Opposition No. 153,234.

Opposer and Applicant hereby jointly request the Board to suspend the above-captioned opposition proceedings until such time as all proceedings are consolidated, pursuant to 37 C.F.R. § 2.117(c) and T.B.M.P. § 510. This will ensure that the consolidated action will proceed in a uniform manner.

This stipulation is submitted in triplicate.


