STIPULATED REQUEST TO EXTEND DISCOVERY PERIOD

Pursuant to Fed. R. Civ. P. 6(b), and TBMP §§ 403.04, 501.03, and 509, Opposer Costco Wholesale Corporation ("Opposer") and Applicants Kirkland Ranch, LLC and The Prudential Insurance Company of America, by and through their attorneys, respectfully request that the Board grant a two (2) month extension of discovery period from June 17, 2003 until August 15, 2003. This is the second request to extend the discovery period and trial dates.

The extension of time has been agreed to by the parties in light of the fact that discovery cannot be completed within the current period, although both parties are diligently pursuing discovery efforts.

Accordingly, the parties respectfully request that the Board grant a two (2) month extension of the discovery period, and reset the remaining dates as follows:


