

Dear Sir:

We are trademark counsel to Kirkland Ranch, LLC. Attorneys for The Prudential Insurance Company of America recorded a security interest against two trademark applications belonging to Kirkland Ranch, Serial Nos. 76/079966 and 76/079967. However, the recordation cover sheet filed by Prudential's attorneys mistakenly identified the conveyance as an assignment rather than a security interest.

We have enclosed herewith a copy of the originally recorded document, a corrected recordation cover sheet and the appropriate recordation fees. Examination of the originally recorded document (the security agreement) demonstrates the mistake on the original cover sheet identifying the conveyance as an assignment: Article 1.27 of the security agreement identifies trademarks as "Personalty;" Article 7.1 of the security agreement grants security interest in "Personalty;" thus, the conveyance recorded was a security agreement, not an assignment.

Therefore, on behalf of Kirkland Ranch, we respectfully request that the PTO substitute the enclosed corrected recordation cover sheet for the erroneous original and change the database identification for the conveyance for these applications to "security interest."


