We have been retained by Johns Manville International, Inc. ("Johns Manville") to represent it in the above-entitled opposition. The Notice of Opposition in the above-entitled proceeding was provided to Johns Manville without the referenced exhibits 1-24. This letter is to request that the Board provide us with a copy of the exhibits so that we may properly respond to the allegations set forth in the Notice of Opposition.


Dear Mr. Sipiora:
