STIPULATED MOTION FOR DISMISSAL OF OPPOSITION WITH PREJUDICE**



(2) That the Opposition be dismissed with prejudice.


It is submitted that all of the issues outstanding in this proceeding are resolved and that the proceeding should be closed. An order of dismissal is earnestly solicited.
