MOTION TO CORRECT APPLICATION

Applicant, FAGE DAIRY PROCESSING INDUSTRY S.A., hereby moves the Trademark Trial and Appeal Board to allow Applicant to correct Applicant's name in Application Serial No. 76/016,810, to correctly identify the Applicant as:

--FAGE DAIRY PROCESSING INDUSTRY S.A.--

Applicant's name was mistakenly misidentified in the application. Pursuant to TMEP §1201.02(c), "[i]f the party applying to register the mark is in fact the owner of the mark, but there is a mistake in the manner in which the name of the applicant is set up in the application, the mistake may be

corrected by amendment." As an example of such a mistake, TMEP specifically states, "clerical errors such as the mistake in addition or omission of "the" or "Inc." in the applicant's name may be corrected by amendment." TMEP §1201.02(c)(3).

Applicant's correct legal name, as translated from the Greek alphabet, is FAGE DAIRY PROCESSING INDUSTRY S.A. Applicant's original application mistakenly used a shortened name Applicant has used to identify itself, namely, Fage Dairy Industries S.A. This was a clerical error made by Applicant's previous attorneys, and Applicant's correct legal name is FAGE DAIRY PROCESSING INDUSTRY S.A.

Applicant sometimes does business under the name Fage Dairy Industries S.A., a shortened version of Applicant's full name. The names Fage Dairy Industry S.A. and Fage-Dairy Processing Industry S.A. were mistakenly misidentified by Applicant's previous attorneys.

To support this Motion, Applicant has attached a Declaration of Applicant establishing Applicant's sole, correct legal name.

Accordingly, Applicant requests that the Board allow Applicant to amend the application to correctly identify the Applicant, as permitted and required by TMEP §1201.02(c).



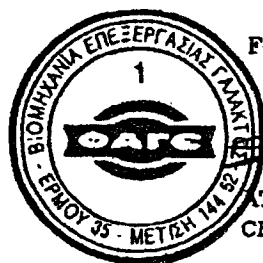
