By the Trademark Trial and Appeal Board:

The following matters are pending before the Board:

(1) the Society for the Prevention of Trademark Abuse, LLC's ("Society") motions (filed September 10 and 24, 2007) to be substituted as the party plaintiff herein; (2) Society's withdrawal (filed September 10 and 24, 2007) of the opposition with prejudice; and (3) Society's and applicant's stipulation (filed September 26, 2007) to dismiss the opposition with prejudice.

The Board will first consider Society's motion to be substituted as party plaintiff herein. A copy of a document reflecting the assignment of the assets of Leo Stoller, including all the stock of Central Mfg. Co., from Richard M. Fogel as Trustee of the Chapter 7 Bankruptcy Estate of Leo D. Stoller to Society was submitted as an exhibit to Society's motion to be substituted. Another copy of that

document is recorded with the USPTO's Assignment Branch at Reel 3605, Frame 0494. See TBMP Section 512.01 (2d ed. rev. 2004). Because applicant consents to the substitution sought and the assignment at issue involves all of the stock of Central Mfg. Co., that motion is granted as well-taken and as consented. Society is hereby substituted for Central as the party plaintiff herein.

In view of the withdrawals of the opposition with prejudice and the stipulation to dismiss the opposition with prejudice that Society filed, the opposition is dismissed with prejudice.
