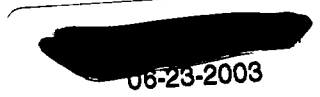

Discovery and testimony periods are set as follows:

- Discovery period to open: **July 02, 2003**
- Discovery period to close: **December 29, 2003**
- 30-day testimony period for party
in position of plaintiff to close: **March 28, 2004**
- 30-day testimony period for party
in position of defendant to close: **May 27, 2004**
- 15-day rebuttal testimony period
for plaintiff to close: **July 11, 2004**

A party must serve on the adverse party a copy of the transcript of any testimony taken during the party's testimony period, together with copies of documentary exhibits, within 30 days after completion of the taking of such testimony. See Trademark Rule 2.125.

Briefs shall be filed in accordance with Trademark Rule 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.

NOTE: The Board allows parties to utilize telephone conferences to discuss or resolve many interlocutory matters that arise in inter partes cases. 6. On information and belief, Applicant's planned use of KANGAROO COURT will falsely suggest a connection with Opposer.


