request to extend the suspension period by sixty (60) days. Pursuant to this request the suspension period will thus end March 5, 2005.


The parties are actively reviewing and discussing a draft Settlement Agreement and believe that extending the suspension period will facilitate the settlement process.


The foregoing request is not being filed for the purpose of mere delay and will not prejudice either party.


