**Elizabeth A. Dunn, Attorney:**

Because the parties are negotiating for a possible settlement of this case, proceedings herein are suspended until six months from the expiration date of the prior suspension, July 10, 2005, subject to the right of either party to request resumption at any time. See Trademark Rule 2.117(c).

In the event that there is no word from either party concerning the progress of their negotiations, upon conclusion of the suspension period, proceedings shall resume without further notice or order from the Board, upon the schedule set out below.

Applicant is allowed THIRTY DAYS from resumption in which to answer the notice of opposition. The parties are allowed the same THIRTY DAYS in which to serve responses to

any outstanding discovery requests. Trial dates, including the close of discovery, are reset as follows:

**Proceedings resume: January 10, 2006**

Period for discovery to close:	July 10, 2006
30-day testimony period for party in position of plaintiff to close:	October 8, 2006
30-day testimony period for party in position of defendant to close:	December 7, 2006
15-day rebuttal testimony period to close:	January 21, 2007

In each instance, a copy of the transcript of testimony together with copies of documentary exhibits, must be served on the adverse party within thirty days after completion of the taking of testimony. Trademark Rule 2.125.

Briefs shall be filed in accordance with Trademark Rule 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.
