MOTION TO SUSPEND GRANTED

Michael Radlovic's motion filed, Sep 01, 2005, to suspend this proceeding to allow the parties time to continue their settlement efforts is granted. Accordingly, proceedings herein are suspended until Oct 01, 2005, subject to the right of either party to request resumption at any time. During the suspension period, the parties shall notify the Board of any change of address for either the parties or their counsel.

If an answer has not been filed, the defendant is allowed until thirty days from the date of resumption to file an answer. The parties are allowed THIRTY

DAYS from resumption in which to serve responses to any outstanding discovery requests.
