

NOTICE OF OPPOSITION

1. ASICS CORPORATION ("Opposer") is a corporation organized and existing under the laws of Japan doing business at ASICS CORPORATION Head Office 1-1, Minatojima-Nakamachi 7 Chome, Chuo-Ku, Kobe, 650-8555 Japan;

2. Upon information and belief, the Applicant Jung AE Park ("Applicant") is an individual having an address of 1100 S. San Pedro St. # J-10, Los Angeles, California 90015.

3. Opposer believes that it will be damaged by the registration of Applicant's application Serial No. 76/552,777 for N-GEL as it relates to goods in International Class 25 for clothing, namely, jeans, jean jackets, t-shirts, sport shirts, jean skirts, pants and shorts, and hereby opposes same.

4. Opposer is the owner of numerous U.S. Trademark Registrations ("Registrations"), including Registration No. 1,877,669 for GEL for athletic shoes, jackets,

shirts, shorts, pants, sweaters, warm-up suits, running suits, wind-proof jackets, wind-proof pants, athletic pants, athletic shirts, athletic shorts, T-shirts, sweat shirts, sweat pants, tank shirts, hats, briefs, and sandals, which was first used as early as April 25, 1986 (hereinafter “**GEL** mark”). This registration is incontestable. A copy of the *TESS* printout of this registration is attached as EXHIBIT A.

5. Opposer is the owner of numerous other U.S. Trademark Registrations that include the term “**GEL**” (hereinafter the “**GEL** marks.”) These Registrations are listed in EXHIBIT B. *TESS* printouts of each of these Opposer’s Registrations are also included in EXHIBIT B.

6. Opposer’s **GEL** mark and **GEL** marks were used, and the Registrations were issued, for the goods indicated therein, on the dates indicated. All of these Registrations were based on applications filed in the U.S. Patent and Trademark Office on dates prior to September 29, 2003, the filing date of Applicant’s intent-to-use application, or were based on dates of use prior to such date. The Registrations of Opposer are valid and existing and are *prima facie* evidence of Opposer’s exclusive rights to use these marks in commerce on the goods specified in these Registrations.

7. Since dates prior to the September 29, 2003 filing date, Opposer has been and is now using numerous other **GEL** marks in connection with the sale, *inter alia*, of footwear and shoes. Opposer has filed trademark applications for the **GEL** marks which are listed in EXHIBIT C. *TESS* printouts of each of these Applications are also included in EXHIBIT C.

8. Opposer uses and has used numerous other **GEL** marks. Attached as EXHIBIT D is a list of some of such **GEL** marks that are in use, or have been used, by Opposer.

9. Opposer’s use of its **GEL** mark and **GEL** marks has been continuous since its date of first use and the mark has not been abandoned. Opposer’s use of a family of **GEL** marks (marks that include the term “**GEL**” including, but not limited to some or all of the marks set forth in Exhibits A-D) has been continuous since long prior Applicant’s filing date. These marks of Opposer are symbolic of the extensive good will and consumer recognition built up by Opposer through substantial amounts of time and effort in advertising promoting and selling its goods under these marks. The **GEL** mark, **GEL** marks and family of **GEL** marks are composed and used in such a way that the purchasing public associates not only the individual marks, but the common “**GEL**” characteristic of the family, with Opposer, ASICS Corporation.

COUNT ONE

Likelihood of Confusion

10. In view of the similarity of the respective marks and the related nature of the goods of the respective parties, Applicant’s mark so resembles any one of Opposer’s marks previously used in the United States and not abandoned, as to be likely to cause confusion.

11. Opposer uses its **GEL** mark, **GEL** marks and family of **GEL** marks in connection with the sale, inter alia, of shoes and footwear. Opposer uses its **GEL** mark, **GEL** marks and family of **GEL** marks on goods that are closely related to the goods on which Applicant listed in its application.

12. In view of the similarity between Opposer's **GEL** mark, **GEL** marks and family of **GEL** marks and Applicant's mark, and the related nature of the goods of the respective parties, Applicant's mark so resembles Opposer's **GEL** mark, **GEL** marks and Opposer's family of **GEL** marks, as to be likely to cause confusion, or to cause mistake, or to deceive.

13. The granting of a trademark registration on **N-GEL** to Applicant would be contrary to Section 2(d) of the Lanham Act, 15 U.S.C. 1052(d), and would violate or diminish the prior and superior rights of Opposer in its **GEL** mark, **GEL** marks and family of **GEL** marks.

14. Opposer will be damaged if Application Serial No. 76/552,777 should be granted because Applicant will obtain statutory rights in the designation **N-GEL** in violation and derogation of the established prior rights of Opposer.

COUNT TWO

Dilution

15. Opposer repeats and realleges each and every allegation set forth in paragraphs 1 through 14.

16. In view of the strength of Opposer's **GEL** mark, **GEL** marks and family of **GEL** marks, the duration and extent of Opposer's use and advertising of its **GEL** mark, **GEL** marks and family of **GEL** marks, the nationwide use of Opposer's **GEL** mark, **GEL** marks and family of **GEL** marks, and the degree of recognition of Opposer's marks, Opposer's **GEL** mark, **GEL** marks and family of **GEL** marks have become famous. Opposer's **GEL** mark, **GEL** marks and family of **GEL** marks were famous prior to the filing date of Applicant's **N-GEL** application.

17. Applicant's **N-GEL** mark and application are likely to cause, and will cause, dilution of the distinctive value of Opposer's **GEL** mark, **GEL** marks and family of **GEL** marks under Section 43(c) of the Lanham Act of 1946, as amended, 15 U.S.C. 1125(c).

18. Opposer will be damaged if Application Serial No. 76/552,777 should be granted because Applicant will obtain statutory rights in the designation **N-GEL** in violation and derogation of the established prior rights of Opposer.

WHEREFORE, Opposer prays that said Application Serial No. 76/552,777 be rejected, that no registration be issued thereon to Applicant, and that this opposition be sustained in favor of Opposer.

A duplicate Notice of Opposition is being filed herewith.
