MOTION ON CONSENT TO CONTINUE SUSPENSION OF PROCEEDINGS

Opposer, with the consent of applicant, hereby moves to continue suspension of the above-captioned proceedings for six (6) months until **November 19, 2009**. Michael Elbein, counsel for Applicant, consented to this motion, which is requested to allow the parties to continue to pursue settlement discussions.

Since the matter was last suspended, the parties have exchanged information for purposes of settlement negotiation. Moreover, the parties have scheduled a telephone conference in order to further discuss a settlement agreement. If accepted, the settlement agreement would resolve this consolidated opposition and a related opposition.

If the Board grants this motion, in the event that the matter is taken out of suspense, the parties request that six months of discovery be allowed and that the discovery cut off be reset to six (6) months after the proceedings resume so that the parties will have the full period of discovery in the event that the matter is not able to be resolved. The trial periods should be reset accordingly.
