
CONSENTED MOTION TO AMEND APPLICATION SERIAL NO. 75/935,690

On November 18, 2004, Opposer United Advertising Publications, Inc. filed this proceeding in opposition to Applicant Home For View, Inc.'s ("Applicant") application, Serial No. 75/935,690, to register the mark HOME FOR VIEW (& Design) for "real estate information services providing an on-line computer database in the field of sales and/or leasing of real estate and real property for marketing real estate over the Internet and providing links to web sites of others featuring information sales and/or leasing real estate."

Applicant moves the Board to amend its application Serial No. 75/935,690 to register the mark HOME FOR VIEW (& Design) to note the following exception to its right to exclusive use: United Advertising Publications, Inc. with a place of business at 100 West Plume Street, Norfolk, Virginia 23510, which claims rights in the mark HOME VIEWS for periodical publications featuring display and classified advertisements in the field of real estate. Applicant claims exclusive rights to the registration of the HOME FOR VIEW (&






**CONSENTED MOTION TO TERMINATE OPPOSITION
IN FAVOR OF CONCURRENT USE PROCEEDING**

On November 18, 2004, Opposer United Advertising Publications, Inc. filed this proceeding in opposition to Applicant Home For View, Inc.'s ("Applicant") application, Serial No. 75/935,690, to register the mark HOME FOR VIEW (& Design) for "real estate information services providing an on-line computer database in the field of sales and/or leasing of real estate and real property for marketing real estate over the Internet and providing links to web sites of others featuring information sales and/or leasing real estate."

The parties recently reached a settlement that ultimately will resolve the above-styled proceeding. The parties hereby request that the Board terminate this opposition in favor of a concurrent use proceeding. Contemporaneously with the filing of this consented motion, Applicant has amended its application initially seeking a geographically unrestricted registration of the HOME FOR VIEW (& Design) mark for "real estate information services providing an on-line computer database in the field of sales and/or leasing of real estate and real property for marketing real estate over the Internet and providing links to web sites of


others featuring information sales and/or leasing real estate," Serial No. 75/935,690, to seek a concurrent use registration of the HOME FOR VIEW (& Design) mark in a specifically defined geographic area. Opposer has no objection to Applicant's amendment of its application, and Opposer will be amending its application for the HOME VIEWS mark, Serial No. 76/534,503, for "periodical publications featuring display and classified advertisements in the field of real estate," seeking a concurrent use registration for the HOME VIEWS mark in a specifically defined geographic area. The Board has held that the termination of an opposition in favor of a concurrent use proceeding in such circumstances is appropriate. Faces, Inc. v. Face's, Inc., 222 U.S.P.Q. 918, 920 (T.T.A.B. 1983); Terrific Promotions Inc. v. Vanlex Inc., 36 U.S.P.Q.2d 1349, 1350 (T.T.A.B. 1995); TBMP § 1113.01(4).
