MOTION TO EXTEND GRANTED

Thirty-day testimony period for party in position of defendant to close: Jun 15, 2006

Fifteen-day rebuttal testimony period

to close:

Jul 30, 2006

In each instance, a copy of the transcript of testimony, together with copies of documentary exhibits, must be served on the adverse party within thirty days after completion of the taking of testimony. Trademark Rule 2.125.

Briefs shall be filed in accordance with Trademark Rule 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.
