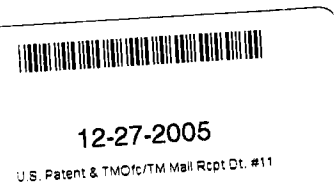

("Applicant"), by their attorneys, hereby stipulate and agree as follows:




