
**CONSENTED REPORT REGARDING PROGRESS OF SETTLEMENT DISCUSSIONS  
AND CONSENTED REQUEST FOR SUSPENSION**

Pursuant to the Board's September 6, 2008 and March 24, 2009 Orders, Applicant, Pennzoil-Quaker State Company ("Applicant"), along with Opposers Chevron Corporation, Chevron U.S.A. Inc., and Castrol Limited ("Opposers"), hereby submits this report regarding the progress of the parties' settlement discussions. Opposers' counsel, William Pecau, consented to filing this report during a telephone conversation with Timothy Kenny on April 21, 2009.

A final settlement document has been agreed to by the parties. As of April 21, 2009, the written Settlement Agreement has been executed by the Applicant and is being circulated to the Opposers for execution. After the Settlement Agreement is fully executed, Opposers will withdraw their opposition without prejudice. Accordingly, the parties request that the Board suspend this opposition to permit the parties adequate time to finalize execution of the Settlement Agreement and to allow Opposers to file the withdrawal. This suspension is not sought for purposes of delay.


