PROPOSED CONSENTED AMENDMENT

United Site Services, Inc. (“Applicant”) has applied for registration of the mark UNITED SITE SERVICES and Design as shown in Application Serial No. 76/561655 (“Application”) in International Class 37 for “rental of temporary construction site fencing” and in International Class 39 for “rental of construction, office and storage trailers.” United Van Lines, LLC (“Opposer”) has opposed this Application in the above captioned opposition (“the Opposition”). In order to resolve the Opposition, Applicant proposes to amend the description of goods and services in the Application to replace the phrase in International Class 39 “rental of construction, office and storage trailers” to now read “rental of storage containers and mobile offices for construction, events, and temporary commercial activities.” All other aspects of the Application’s description of “goods and services” shall remain the same.

Opposer consents to this amendment and is filing concurrently a withdrawal of the

Opposition, contingent upon acceptance by the Board of this proposed amendment.
